

TERMS AND CONDITIONS

1. TM & SONY Merdeka photo contest through www.tm.com.my is organised by Telekom Malaysia Berhad (Co. No. 128740-P) ("TM") and is opened to all TM & SONY customers including Clause 2 below.
2. Participants must be a TM & SONY customer with minimum purchase of RM10 iTalk card for each contest submission and submission is only through www.tm.com.my.
3. The following group of individuals are not eligible to participate in the Contest:
